### **H-LAT GUIDELINES – STUDENTS**

#### **General Instructions:**

1. The H-LAT 2022-23 examination will be held in ONLINE mode.
2. H-LAT 2022-23 will be conducted on Multiple dates.
3. **H-LAT examination is not compulsory for students who have already appeared for other Law Entrance Examinations in 2022-23.**
4. **H-LAT examination is conducted for students who have not appeared in any other Law Entrance Examinations in 2022-23.**
5. **The appearance in any Law entrance examinations 2022-23 is mandatory for admission to B.A. LL.B. (Five Years Integrated Program 60 intake), B.B.A. LL.B. (Hons) Five Years Integrated Program 60 intake) and LL.B. (Three Years Program 60 intake)**
6. The applications must be submitted ONLINE only on the following link:

7. The date of examination is scheduled on 20th May 2022 from 11 AM to 12.30 PM (Subject to revision in case of necessity)
8. The online enrolment for H-LAT 2022-23 will open on 10<sup>th</sup> May 2022 and close on 18<sup>th</sup> May 2022.
9. The application form must be completed in all respects. Incomplete application forms shall not be considered. The candidates shall fill and submit the application form well in time to avoid last-minute hassles. The University shall in no case be responsible for any incomplete information or misinformation or inconvenience faced by the candidate in this regard.
10. The candidates are first required to register themselves at the H-LAT 2022-23 website by using their personal mobile number and e-mail Id. Upon registration, an OTP will be sent to the registered mobile number for validation. Once the mobile number is validated, candidates can login using the registered mobile number and the password provided at the time of registration.
11. Please fill the form carefully. The Name of the candidate and the parents shall be spelt correctly in the application as it appears in the Certificates/Mark sheets/Identity proof. Any change/alteration found may disqualify the candidature.
12. Updates to the application form will not be entertained after the closure date.

13. The H-LAT 2022-23 application fee **once paid** is non-refundable and non-adjustable.
14. If a candidate has filled in more than one online application form, the candidate's last online application form only will be considered. In such cases, the application fee for the previous application forms will not be refunded.

**Documents to be uploaded with the Online Application:**

1. Front facing passport size recent photograph with plain background
2. Signature of the candidate
3. Category certificate if you are applying under SC/ST
4. Relevant certificate issued by a competent authority if you are applying if the candidate is Pw.D.
5. Qualifying Examination marksheet.

**Application Fee:**

1. Application fees can be paid online only.
2. Application fee **for General candidates is Rs. 1000/-**
3. Application Fee **for OBC candidates is Rs. 500/-**
4. Application fee **for SC/ST category candidates is Rs. 500/-**
5. The candidates themselves will have to bear the bank transaction charges for remitting the fee online. The actual bank transaction charges will be displayed on the payment gateway page after candidates choose the mode of payment.
6. Application Fees are non-refundable.

## HSNC University H-LAT 2022-23 Eligibility Criteria:

To appear in H-LAT 2022-23, the students must fulfill the following **eligibility criteria**:

PROGRAMS	ELIGIBILITY CRITERIA
<ul style="list-style-type: none"><li>• <b>B.A. LL.B.</b></li><li>• <b>B.B.A. LL.B. (Hons.)</b> (Five Years Integrated Program)</li></ul>	Standard XII (10+2) pass or an equivalent examination from any recognized Board with a minimum of <b>45% marks or equivalent grade for General category candidate, 42% marks for OBC category candidate &amp; 40% marks or equivalent grade for Scheduled Caste/Scheduled Tribes category candidates</b> ).
<b>LL.B.</b> (Three Years Program)	Passed graduation (10+2+3) in any discipline from a recognized college/university having secured a minimum of <b>45% marks for the General category, 42% marks for OBC category and 40% in aggregate for SC/ST category</b> .

### H-LAT 2022-23 Eligibility Criteria for NRI students:

A student is eligible to apply as a Non-Resident Indian (NRI) if he/she has appeared for either 10th or 10+2 (equivalent to the Indian 10th or 12th) examination outside India. It is mandatory for NRI students, who have appeared for their 10th standard exam outside India and 12th in India, to appear for H-LAT as applicable.

### H-LAT 2022-23 Exam Guidelines for PwD Candidates:

Candidates applying under the Pw.D. category will not be provided with any facility of a scribe by the conducting authority. All the visually impaired and candidates with adversely affected writing speed permanently can bring self-paid scribes to the exam centre with them.

### Rules applicable for the use of Scribe by Pw.D. candidates:

- Candidate appearing in the exam cannot appear as a scribe for any other candidate. The scribe of one candidate cannot be a scribe for other candidates.
- **A candidate who is eligible and wishes to avail of the benefit must notify the same in the online application form. Any subsequent request will not be addressed.**
- **Scribes can be of any academic background.**
- **Both candidate and scribe must give an undertaking stating that the scribe fulfills the H-LAT 2022-23 Eligibility criteria laid by the exam conducting authority. The candidature of the applicant is at risk if any one of them is found ineligible for the exam.**
- Candidates using scribe will get an extra time of 20 minutes per hour.
- Candidates who have registered in advance can only avail of this facility as compensatory time will be system-based and it can't be allotted to candidates who don't notify about the same in H-LAT 2022-23 Application Form.

**Guidelines for Candidates with Locomotors Disability and Cerebral Palsy:**

A candidate whose writing hand is permanently affected (minimum 40% impairment), thus affecting the performance of the candidate, will be eligible for extra time of 20 minutes per hour or otherwise advised.

**Guidelines for Visually Impaired Candidates:**

- The candidates who suffer from not less than 40% disability may opt to view the content of the online test in enlarged font and these candidates will be entitled to extra time of 20 minutes per hour
- If visually impaired candidates avail the facility of a scribe, they will not get the option of viewing the questions in an enlarged font. However, such candidates will get any extra time of 20 minutes per hour or as advised by the authority.
